COLORADO SPRINGS 20-23 MAY: MISSION ACCOMPLISHED

The 55th Strat Recon Wing Association held its 19th reunion in Colorado Springs, CO, 20-23 May. The scenic splendor and area attractions added to the hospitality suite bull sessions, renewing friendships and camaraderie for the more than 320 55th veterans, spouses, family members and friends who made it to the funfilled four days' festivities.

The reunion committee, headed by Keith Smith, performed an absolutely superb job of planning and executing the reunion registration and program. Numerous other volunteers helped at registration and in the hospitality suite during the reunion.

Despite the inexcusable fiasco by the Sheraton staff on Wednesday, which held up registration for more than 100 early arriving members, for three and a half hours and longer, earnest reuniting commenced in the lobby as well as in the hospitality suite.

Thursday's highlight was the outing to Cripple Creek, a historic mining town, now a tourism and gambling enterprise. It was an exciting afternoon and evening, tempered by whether one won or lost. Also, the Association Board of Directors convened on that day to recap accomplishments since the last reunion,

and to prepare an agenda for the general membership meeting.

Through the wonders of e-mail, the Board was able to have a meaningful exchange of views on matters of import and transact business on a near realtime basis prior to the reunion. Among those were ideas on how to encourage delinquent to rejoin members Association, and encourage the recruitment of new members, particularly from the active duty Wing, 'younger' retirees and friends and associates of the 55th SRW.

The Friday obligatory golf outing at the USAF Academy Eisenhower Blue Course resulted in a tie score of 69 for two foursomes. Possibly the most important is the excellent rapport established between the Association and the 55th Wing at Offutt. This evolved largely due to the leadership of the current wing commander, BGen Ambrose, Garv recognizes the value of support from the retired community, and that the Association and its members valuable are resources.

SOME MEMORABLE MILESTONES IN AVIATION

DID YOU KNOW:

1. That a former 55th SRW commander achieved a flying speed record which stands to this day?

On July 29-30 1947 Lt. Col. O. F. Lassiter set a recognized class record for speed over a 10,000-km closed circuit without payload (pistonengine aircraft) of 273.194 mph in a B-29A Superfortress at Dayton, Ohio.



2. What types of aircraft were used in the first air-to-air, jet-to-jet refueling?

The first jet-to-jet air refueling took place between a Boeing KB-47 and a "standard" B-47 on 1 September 1953.

Note: The first air-to-air refueling of any kind took place on 12 November 1921. Wesley May, with a five-gallon can of gasoline strapped to his back, climbed from the wing of one aircraft to the wing of another. Ed.

3. Who was the first American president to fly?

On 11 October 1910 former President Theodore Roosevelt became the first chief executive to fly. He went aloft as a passenger in a Wright biplane over St. Louis, MO.

4. In which service Henry H. "Hap" Arnold was a five-star general?

Arnold was promoted to five-star rank in the U.S. Army (General of the Army) on 21 December 1944.

On 2 June 1949, by a special act of Congress, he was given the rank of General of the Air Force.

5. Other than the B-25 raid on Tokyo led by LtCol Jimmy Doolittle on 18 April 1942, what other uses of Navy aircraft carriers were made by Army Air Forces or Air Force crews and aircraft?

On 8-11 November 1942 Army P-40s took off from carriers to support the invasion of North Africa. The pilots landed at land bases.

Note: On 30 October 1963
Navy Lt. James H. Flatley
landed a Lockheed C-130F on
the Aircraft carrier Forrestal in
a test to see if the Hercules
could be used as a Super COD
(carrier on-board delivery)
aircraft. He eventually made 21
unarrested full-stop landings
and a like number of unassisted
takeoffs. Ed.

6. Which U.S. military aircraft was manufactured in the greatest number?



On 29 December 1939 at Lindbergh Field, San Diego the Consolidated XB-24 Liberator made its first flight. More than 18,100 would be built in the next five and a half years

7. Which two military aircraft, one U.S. and the other Russian, made their first flights in December 1947?

The XB-47 first flew on 17 December 1947 and the MIG-15 first flew on 30 December 1947.



8. Which U.S. fighter aircraft accounted for the most shoot-downs in WW-II?

Although its first operational use was not until 31 August 1943, more than 20 months after Pearl Harbor, the Grumman F6F Hellcat accounted for more kills than any other U.S. fighter

9. What is the world's largest aircraft today?

The Russian AN-225. As evidence of the thaw in US-

Russian relations, the Russian AN-225 and two MIG-29 fighters refueled at Elmendorf AFB on 6 August 1989.

10. When the last WW-II Army Air Forces combat flyer retired?

Col. (Dr.) Thomas C. Cook saw action as a B-24 navigator in Europe and transferred to reserve status in 1948. He returned to active duty in 1976 and retired on 9 November 1990.

A MEMORY OF COL. LASSITER

One day in October of 1957, at squadron roll call in the 343rd SRS, I was directed to report to Wing Headquarters. No explanation as to why.

This made me apprehensive.

A few months earlier I been summoned had to Headquarters because of something I had said as president of the Parent Teachers Association, at my daughter's elementary school in Topeka. Regarding some planned PTA event, I had stated that such and- such a date was a poor one as a number of fathers would be gone at that time.

A major, and squadron commander in the 90th Wing, who was present, considered my statement a gross security violation and reported the incident to Wing Headquarters. To make his case persuasive, he alleged that I had stated number troops and of aircraft. destination and departure, and return dates of an upcoming deployment. I was able to wriggle out of that situation by proving that I did not know, and could not have known, much of that information.

Nevertheless, I was apprehensive about being called up to Headquarters.

The building that housed Wing Headquarters was a World War II relic, as were most of the buildings on Forbes AFB in the fifties. It had about as much class as a prairie hogan. I was directed to a tiny room holding twenty or so other first lieutenants, most of whom I knew and all rather senior. We quickly came to the hopeful speculation that we had been summoned to get the good news that we were to be promoted.

After a longish wait, a beautiful young woman with a drop-dead shape opened the door and, in the manner of a basic training drill sergeant, told us to pipe down or we would be in deep trouble.

After another half hour, the door opened and the Wing Commander and the pretty lady stood there. We all jumped to attention.

Colonel Lassiter was a handsome man of medium build, muscular, erect, perfectly groomed and with a fresh cigar in his mouth. (It was the LeMay era in SAC.)

With an expressionless stare, he gazed at us for some moments and without looking at his pretty aide, he reached for a sheet of paper she was holding.

Taking the cigar out of his mouth, he mumbled, "Looks like the Air Force has screwed up and is promoting you men."

Still mumbling, he proceeded to read our names and effective dates of our becoming captains. Many of the simplest names he mispronounced. He got mine right but gave the incorrect effective date.

When he had finished, he handed the list back to "the body", turned on his heel and left in a trail of cigar smoke. No congratulations. No "thank you for earning your pay." Nothing.

In addition to having established a B-29 speed record, O. L. Lassiter had distinguished himself in other ways. He had the Air Force served as technical advisor for a motion picture about SAC, starring Jimmy Stewart and June Allison. He apparently had hit it off congenially with the Hollywood crowd and had become friends with a number of celebrities.

During Lassiter's tenure as 55th Wing Commander, the

singer and actor Allan Jones periodically visited the Lassiter family, and a number of times appeared with them at the Officers Club. Inevitably when he did, he went to the microphone and sang "Donkey Serenade." This was a number he had sung in a film years earlier and, in the fifties, was about as familiar to the Forbes officers as Plato's "Republic."

When he left the 55th, Lassiter moved on to SAC Headquarters where he was promoted to Brigadier General. Not long afterward he left the Air Force and became chief executive of a jet aircraft charter service. Jimmy Stewart was one of his partners as was General LeMay. By Ben White

QUEST TO FIND LOST REMAINS OF FORBES FLIER STILL BAFFLING

It was the most promising lead Topekan Maria Goforth McAtee had gotten in years about where the remains of her late husband might be located.

An American with the US-Russian Joint Commission on POW-MIA had called and told her that a team planned to dig up two unmarked graves in a tiny cemetery in the far northern reaches of Russia.

"He told me there were eight graves and that two of the graves unmarked." were McAtee said in an interview.

The small cluster of graves, called the Severomorsk Military Cemetery, wasn't too far from where a Forbes Fieldbased (sic) RB-47 airplane was shot down by a fighter of the former Soviet Union over the Barents Sea on July 1, 1960.

McAtee's husband. Capt. Oscar Lee Goforth, was among six airmen on the plane, which had been modified into a reconnaissance aircraft. Goforth and two other officers were in the cramped modified bomb bay of the six-jet bomber working to pick up radio intercepts with their electronic eavesdropping gear when the

plane was attacked. The plane was assigned to the 55th Strategic Reconnaissance Wing at Forbes Air Force Base, which was a busy Strategic Air Command base during the 1960s and 1970s. (*sic*)

The RB-47 went into a flat spin to the left after being hit by cannon fire from a Soviet MIG fighter and reportedly blew up over the sea.

Two members of the crew, then Capts. John R. McKone, the navigator, and Freeman B. Olmstead, the copilot, survived the shootdown and were picked from the frigid Barents Sea by a Russian trawler. They spent six months Moscow's infamous Lubyanka prison before being freed in January 1961 as a Russian gesture of good will toward the new presidential administration of John Kennedy.

One body from the RB-47, that of Maj. Willard G. Palm, the pilot, was recovered from the sea and turned over to American authorities on July 25, 1960.

The body of another of the crewman, Capt. Eugene Posa, supposedly was recovered by the Russians in October 1960 and taken to the Severomorsk area.

But no bodies, nor any remains, of Goforth and the sixth member of the RB-47 crew, Capt. Dean Phillips, have ever been found.

Despite its promise, the Severomorsk Cemetery lead was a false alarm.

"They told me they were Russians," McAtee said last week, of the two bodies that were exhumed from the cemetery, "One had been buried for 16 years and one had been there longer, and that one had on his uniform."

It was a big letdown for the Topeka woman who has waited 38 years to find out what happened to her first husband.

"I was disappointed," she said. "But I'm fine. There's nothing much I can do."

"But these people who are working for the American-Russian Commission, they're wonderful. The officer who called said there is another cemetery over there that they have people checking into. It's in the general vicinity, but on the other side of the bay

"They're buried in Russia somewhere and I said to this guy, 'You know somebody knows.' And he said, 'I know somebody knows where they're at.' There are a lot of people who have come forward."

The widow of Capt. Phillips, Pat Phillips, reached at her home in Sacramento, CA, said she also was disappointed at the news from the U.S.-Russian Commission representative who contacted her.

"Well, you know, your hopes get up and then they go down," Phillips said. "You try to tell yourself, 'well, don't get your hopes up on the roof.' But I'm doing all right. My daughter lives with me and we fortify each other."

Larry Greer, a spokesman for the Pentagon POW/MIA office, said: "Even when it's not always the answer you want to hear, we want people to know what we're doing, where we're going, that we're not doing anything undercover here.

"We are always hopeful, that's why we do this. The reason we went to the cemetery was because we had a lead from a Russian autopsy report that said they buried an individual who wasn't Captain Goforth."

Greer declined to identify either of the bodies that were exhumed. But Maria Goforth said she thinks they were looking specifically for the body of Eugene Posa, whose remains were reportedly sent to the Severomorsk area after it was recovered, but which have never turned up.

Maria said she thinks the U.S.-Russian Commission team exhumed the graves looking for Posa, hoping it would lead them to the bodies of her husband and Dean Phillips.

Greer said there was other anthropological evidence recovered from the grave that solidified the conclusion that the remains were those of Russians and not Americans.

Greer said the other cemetery across the bay from the burial plot that was exhumed "is a tenuous lead."

"Our concern is that there's not even a village left to point at. But we're going to check it out," he said. "Based on cursory observation of it, the cemetery that is allegedly there is no longer there.

"But we're not going to turn anything down."

McAtee and Phillips say that attitude gives them hope that their long wait to find out what happened to their husbands may finally be drawing to a close.

"I feel very positive about this," Phillips said. "I feel maybe we got let down this time, but there are people who are working and plugging away.

"And Maria feels the same way I do. Maria told me, "I think something positive is going to happen."

The Board of Directors embarked on a concerted campaign to encourage delinquent and/or forgetful members to rejoin the flock and become members in standing once again by catching up on their dues. In recent times the Association roster had more than 1400 names listed of which 800 were **not** paid up members. Yet those folks were getting newsletters the same as dues payers.

The most recent effort to reclaim members was after the May reunion with a postcard sent to those who had not paid any dues since at least 1994, or were only late a year or two. Of the 620 members invited to bring their dues up to date, 226 responded with \$3,985 added to the treasury! The Association gladly welcomes back those comrades.

The Board and the reaffirmed membership the of "no policy dues. no roster." newsletter, no Members who were **not** in good standing as of 1 August are deleted from the mailing list and from the latest published roster.

We have been asked why we have no life membership program. The Board considered and rejected the idea because of legal and accounting complications. The monies would have to be prorated over the life expectancy of each paid life member and would have to be budgeted and accounted for those years. However, the treasurer does **credit** for advanced vears if/when members pay more than the required \$10.00 annual dues.

55th Strat Recon Wing Association Membership Meeting Colorado Springs, CO 23 May 1998

Secretary's Minutes

- 1. The President called the meeting to order at 1245 hours. (Notice of meeting was in Feb 98 Newsletter, page 1, third column.)
- 2. The President called for the minutes of the previous meeting. The Secretary reported there were no minutes to read. (The previously serving Secretary did not forward minutes from September 1996.)
- 3. The President called upon the Treasurer for his report.
- 4. The President called upon the Vice President for his report. Robb Hoover announced that the National Reconnaissance Office (NRO) in Washington was preparing a history of reconnaissance and was interested in interviewing persons with significant accounts of strategic reconnaissance, and also in acquiring relevant photographs. Taped interviews were being conducted during the reunion.
- 5. The President expressed his appreciation for the work of the Board during his tenure, with specific reference to the work of Don Griffin on the Association web site, and to Sam Pizzo for his work on the nominated slate of Board members, and on the design of the Association sympathy card.

The President also outlined the procedure for reporting the deaths of members so as to insure accuracy of those reports for publication in the Association newsletters and on the web page.

- 6. The President called upon Sam Pizzo, chairman of the nominating committee, to present his list of nominees to the membership. Nominees were: Bill Ernst, Robb Hoover, Ben White, Charlie Waters, Errol Hoberman, Max Moore, Don Griffin, Sam Pizzo, Sparky Adams, Jim Maloney, LtCol Bo Marlin, TSgt Craig Kibbe. There being no nominations from the floor, a motion was made to close the nominations. It was seconded and carried. Another motion was made to elect the nominees by acclamation. Seconded and carried.
- 7. The President explained that the intended site of the next reunion, San Antonio, was rejected based on Lloyd Navarro's report that accommodations were too expensive. The Board recommended considering other locales. Charlie Waters volunteered Ft Walton Beach, FL, again, and Don Gurney proposed Reno/Tahoe area. The membership voted for the Reno/Tahoe area and Gurney was asked to explore the possibilities of both Lake Tahoe and Reno areas for the 1999 reunion and report back to the Board within a month.
- 8. The President explained the amendments to the Articles of Incorporation and the Bylaws which the Board had coordinated and completed, and the membership voted to accept those amendments.
- 9. Other discussions included Sam Pizzo relating that the current Board and Omaha area caucus were responsible for establishing the highest level of rapport with the active duty 55th Wing. Max Moore explained how the Association dual-shield pin evolved, giving full credit to Bill Ernst for the idea and commissioning.
- 10. Sam Pizzo and Sparky Adams reported that the audit of the Treasurer's books showed they were in good order.
- 11. The meeting was adjourned at 1345.
