## 24<sup>TH</sup> REUNION 9-13 March 2005 – San Diego, CA



The Red Lion Hanalei Hotel was HQ for yet another great 55<sup>th</sup> SRW Association reunion. Bill and Carol Lewis were responsible for the planning and organizing the four days' festivities, and an outstanding job it was! Kudos from the attendees were forthcoming throughout the week about how well organized the events were.

The crowd began rolling in as early as Monday the 7<sup>th</sup> to take advantage of the many great attractions and scenery San Diego offers. But the doings began in earnest with registration on Wednesday afternoon in the Hospitality Room.

Almost three-quarters of the nearly 280 attendees were there by the end of the evening, and the joint was hopping! Warm greetings of long time friends and comrades, and reminiscing abounded.

Of course that area was the hub of activity, and very convenient for meeting and greeting even during relaxed times, all through the week with generous hours of service every day of the reunion. Dan the Bartender Man said, "I haven't worked this hard since spring break at Ft Lauderdale." (High praise indeed.) The Lewismobile's trips to replenish supplies were several and often during the week.



Tours and Attractions

Attendees had a variety of tours to take in order to enjoy the historic area over the next four days, or they did it on their own. There was a grand tour of the city, a shopping excursion to LaJolla, a run to Tijuana, and other outings.

Many took advantage of the Old Town Trolley to see the Mexican flavor of restaurants and shops; or stop off on Coronado Island and the majestic Del Hotel; at the Seaport Village or other interesting locales. Of course there was the world famous San Diego Zoo, one of just three in the US displaying Giant Pandas.

Balboa Park offered fourteen varied museums, including an aerospace museum with an excellent assortment of historic aircraft, and the Museum of Man, in addition to the very large, green activity areas, and the world's largest outdoor pipe organ.

The obligatory golf outing was ably coordinated by **George Back**, and about 30 duffers and hackers hit the course at North Island NAS on Friday morning. The winning foursome was **George Miller**, **Jim Maloney**, **Tom Garrity** and **George Ross**. The main prize was a three year extension of Association membership. (*Miller commented that since he was already a life member, that his life expectancy would be expected to be three years longer*. Rim shot, ba-da-bing!)

A delightful highlight was the dinner cruise on San Diego Bay Friday evening. Nearly 200 **55thers** occupied most of the boat's two dining decks. The crew was professional and efficient, and the elegant three course meal was superb. The 3.5 hour sail offered a magnificent view of all aspects of San Diego's glittering skyline and surrounding vistas; including passing the USS Ronald Reagan, the world's largest aircraft carrier, and cruising under the Coronado Bridge.

### Saturday's Schedule

Saturday's agenda was jam packed. The Association general membership meeting kicked off the morning. Business was recapped by **President Bill Ernst**, various officer and committee reports were given, and a new Board of Directors was elected. (Note: Complete minutes of that meeting are published later in this newsletter.)

Immediately following the meeting, a presentation was given by **Rear Admiral (Russian Navy – Retired) Boris Novyy** on the joint efforts to



document and locate the remains of American reconnaissance crewmembers who were victims of Cold War incidents. Interpreter and US-Russia Joint Commission on POW/MIAs member, LtCol Michael O'Hara, US Army, explained the work of the commission to determine the fate of Cold War, Korean War, and Vietnam War American casualties in Soviet control. He works closely and diligently with Adm Novyy in that effort.

Readers of the October 2004 Videmus Omnia newsletter will recall an article by Pat Phillips recounting that Adm Novyy hosted the visit to Russia in May of that year by Pat, her daughter Roxanne, and Maria Goforth McAtee and her daughter, Linda Schilder. The invitation by the Association for Adm Novyy to attend the reunion was, in part, to reciprocate for his hospitality.



An RC-135 from the 55<sup>th</sup> Wing at Offutt arrived that morning at North Island Naval Air Station. **LtCol Chris Cohoes** and six other crewmen provided a tour of the aircraft for several reunion attendees, to include Adm Novyy.



(All involved could readily grasp the irony in that, and how history has moved along since the Cold War.)

Those who toured the plane appreciated how the crewmen were eagerly engaged in proudly showing their 'place of work'.

The crewmembers were the guests of the Association at the banquet that evening.

Saturday evening festivities began with a cocktail hour, and a poolside performance by the Marine Band from the San Diego Marine Recruiting Center. It was a rouser well received by a most receptive audience; and in fact, heard by patrons throughout the hotel complex whether they wanted to or not. Many were seen on their courtyard balconies enjoying the show.

### The Grand Banquet

The assemblage then proceeded to the banquet hall for the climatic event of the reunion. Pres Ernst made welcoming remarks; the Pledge of Allegiance was recited by the audience; and Ernst introduced the head table and special guests. He then gave well deserved recognition and praise to Bill and Carol Lewis for such a terrific job in organizing and running the reunion. The attendees responded with a sincere and prolonged standing ovation.

Appropriate toasts were given, and the Reverend **Fred Glass**, the Association de facto chaplain, gave the invocation. After the members enjoyed another superb meal and dessert, the program continued. Ernst announced Association's the elected officers and Board of Directors to serve until the next reunion.

Newly-elected **President Jim Thomas** took the podium, and with retiring-Vice **President Hoover**, gave appropriate recognition and appreciation to Ernst for his nearly nine years' service as president



of the Association. Ernst was presented with a mantel clock adorned with two Cold War Memorial coins (front and back displayed), and an engraved

plate honoring him. He was accorded a standing ovation, as well.

Special presentations were given to Admiral Novyy in recognition of his valuable assistance and cooperation in researching Cold War incidents. Thomas gave him an Association tie; then Pat Phillips presented him with an Association pin.

Pres Thomas then gave a summation of the potential sites for the next reunion in the fall of 2006. He stated that the Board of Directors would be researching whether to select Washington, DC, or Omaha, and would seek volunteers to plan and



run same. He made closing remarks and bid all safe travels. The crowd adjourned for one final, farewell session in the hospitality room.

On Sunday many reunion attendees partook of the hotel's sumptuous and expansive champagne brunch, while others headed for destinations across the nation. There were several folks who remained in the area for another day or two to visit friends, relatives, or hit attractions in San Diego they had previously missed.

In summation, this was one more in the series of spectacular reunions for members and friends of the Fightin' Fifty-Fifth, and we all look forward to the next one in the fall of 2006.

Pleased with his success, she told him his work was "a noble cause". His last promise to her was to never stop in that search. The search will continue; he remains on track with a plan. We are all the better for building this personal relationship between the Admiral and many of our members. ## MEMBERSHIP MEETING MINUTES

12 MARCH 2005 - SAN DIEGO, CA RED LION HANALEI HOTEL BALLROOM

The meeting was called to order by President Bill Ernst at 0800. He welcomed the assembled members and then introduced the current Board of Directors in attendance: Vice Pres Robb Hoover, Secretary Max Moore, Treasurer Hoberman, Webmaster Don Griffin. Joe Gyulavics, Jim Maloney, Jim Thomas, George Ross, Sam Pizzo, Sparky Adams. He also recognized those not in attendance: Charles Waters, Mike Cook, Dennis Haun, LtCol Will Hampton, LtCol (Col-select) Jay Strickler, and outgoing member Capt Beth Kelley Horine (deployed to Baghdad, Iraq, and going PCS to RAF Lakenheath, UK, thereafter), for their service to the Association.



Ernst called for the secretary to read the minutes from the 6 September 2003 Dayton reunion membership meeting. Thomas moved that we dispense with the reading. **Darrel Kirbie** seconded. Motion carried.

Treasurer Hoberman gave the Association financial report stating, "the Association is still solvent" with liquid assets of \$20,972 in checking and savings. He also reported that there are 1097 members in good standing (a gain of 33 since 1 October 2004), which included 164 widows and 43 associate members. The president noted that Maloney and Ross had completed the required audit of the treasurer's records and reported found "all to be in order".

Ernst then gave a comprehensive report on Association business in the past year: the Cold War Memorial financial commitments have been met; and the brick patio is essentially complete to include the replacement and/or addition of any bricks that were incorrect, defective or missing; and that trees were planted behind the memorial to enhance the area. The Association made significant donations to the Air Force Memorial (\$1000 in January 2004), the 55<sup>th</sup> Wing Birthday Ball fund (\$1000 annually), and to the Tuskegee Airmen Reunion held in Omaha in August 2004 (\$600).

He also gave explanations of the 55<sup>th</sup> Wing Hall of Fame and the Association Award for Excellence processes, and recognized the leadership of Awards Chairman Cook in those endeavors. He stated that the 55<sup>th</sup> Wing leadership was pleased with the results of how the Association had conducted the selection process since assuming the responsibilities the last two years.

Ernst made comments regarding his retirement as Association president, acknowledging it was time for new leadership and a fresh outlook. He also had high praise for the all the Board of Directors members he had worked with in his nine-plus years' tenure. He stated it was his great honor and privilege to have served the Association, and that he would continue to do so.

VPres Hoover reported that the current 55<sup>th</sup> Wing leadership re-ignited interest in producing a sequel to Bruce Bailey's book, "We See All". The new book would cover history of the 55<sup>th</sup> from the late 1960s to the current times. A core committee of the Association is working with the 55<sup>th</sup> Wing Historian's office on this effort. (Ongoing.)

Hoover noted that Bailey had passed to the Association the rights to the original book for publication, and expressed the Association's gratitude to Bailey for that action. He then recapped the most recent "Tales of the 55<sup>th</sup>" event (18 February), and said the tradition would continue next year and that Thomas has volunteered to assume the responsibilities for organizing it.

Webmaster Griffin stated that the effort to find "new blood" to maintain the Association web site resulted in Maloney volunteering to begin assumption of those duties and responsibilities once he passes a 'stand/eval.'

The president recognized Nomination Committee Chairman Pizzo, who announced the slate of nominees for the Board of Directors: for reelection: Moore, Hoberman, Griffin, Gyulavics, Cook, Haun, Thomas, and Ross. Plus, nominees for first time election: Ricky McMahon, Fox Censullo, Kevin Todd, to make up the maximum allowed eleven elected Board positions. Pizzo added that she. Adams and Waters would remain as permanent Board members, with Ernst, Hoover and Maloney opting for that status, each having been elected four or more times. The active duty representatives from the 55<sup>th</sup> Wing, as approved by the Association Board, are LtCol Will Hampton, 338<sup>th</sup>CTS Commander, and LtCol (Col-sel) Jay Strickler, 55<sup>th</sup> Wing Chief of Staff.

The floor was opened for nominations from the floor. There being none, Adams moved that the slate of nominees be accepted and elected by acclamation. **Norm Paul** seconded. Motion passed by voice vote of the members.

President Ernst commented on the new Board members' qualifications and long affiliation with the Wing and this Association, and he noted the movement toward younger leadership as being a positive and needed action for the Association's future. He then announced that the newly elected Board would meet in the area of the podium immediately following the adjournment of the membership meeting.

He then recognized the reunion organizers, **Bill** and **Carol Lewis**, for their superior, dedicated hard work in orchestrating a superb reunion, and "for doing such a terrific job." The membership responded with a rousing standing ovation.



The floor was opened for discussion on where to hold the next reunion in the **fall (Sep/Oct) of 2006**. Omaha, Tucson and Washington, DC, were

all suggested, but no one volunteered to lead at any of those locations (or anywhere else). It was noted that the last gathering in Omaha was in September 1996, and that perhaps it was time to return to 'Recca' for the exposure and reconnection to the active duty troops of the 55<sup>th</sup> Wing at Offutt. Also mentioned was that DC would be hosting the dedication of the Air Force Memorial and Air Force Association national convention in September 2006.

A straw poll indicated that Washington, DC, led in the voting, with Omaha a very close second. It was determined that the Board would have this as open for further action. Once a decision is reached, announcements will be made via the Assn web site, newsletter, and e-mails to spread the word as quickly and widely as possible.

Moore commented on the pending arrival of an RC-135 aircraft from Offutt, and the planned static display tour, being coordinated via cell phone by Thomas. He stated that further information and details would be announced and posted in the Hospitality Room.

He also took the occasion to elaborate on Pres Ernst's leadership and the many significant contributions and milestones which occurred during his time in the presidency as the Association grew in numbers and function, and as it became a more solid and relevant organization. The membership again responded with a standing ovation.

Griffin moved the meeting be adjourned. Bill Simon seconded. Motion carried at 0938.

## **MEMBERSHIP REPORT**

As of 1 May 2005, the Association had 1024 members in good standing, 162 of which are widows, and 43 associated members. This is a net decrease of 10 members since 1 October 2004. There were 63 lapsed or dropped memberships, but

they were nearly balanced out with new and returned members.

The Association has members in **49 states** (still no Alaska rep), Guam, Puerto Rico and APOs in Europe.

The number of **active duty members** continues to rise as interest has picked up due to the Association's exposure in the Offutt area, and as members continue to recruit.

Membership status indicators are herein defined: 2005 on your address label means that your dues expire at the end of that year, and you are a member in good standing. Any other year shown indicates when your dues expire, or have already expired.

In the latter case, its time to reup, now.

LM designates a life member. (Persons who contributed \$500 or more to the Cold War Memorial, and those who have provided special 'over and above' service to the Association.) *Dues not required*.

**HLM** denotes Honorary Life Member (Widows). *Dues not required*.

**AM** indicates associated members, such as certain 55 Wing senior staff positions and other individuals with a special relationship with the Association. *Dues not required*.

**NLR** is a **new** designation to indicate that the newsletter goes to individuals and organizations for the benefit of the Association. *Dues not required*.

If your dues expired 2004, \$20.00 is due to include 2005. One year's dues is \$10. \$25 will update your membership for three years beyond what now shows as an expiration year.

NOW is the time to renew.

If your dues expired in 2004, this is the last newsletter you will receive unless you renew your membership.

Please remit dues to **55SRW Association** and mail to Errol Hoberman as soon as practical. For those who receive this newsletter via regular post, an Association-addressed envelope is enclosed for your convenience.

New members receive the Association's dualshield lapel pin and the 55<sup>th</sup>SRW Cold War Memorial coin when they join. Members desiring replacement or additional pins can get them from Errol for \$5.00 prepaid (if you want more than one pin, the cost is just \$3.00 for each additional pin if mailed at the same time; i.e. one pin, \$5, two pins, \$8, three pins \$11, etc.).

Ernst and Moore have pins and coins, as well, so members in the Omaha area can get the pins from them for \$3.00 without the S/H. Extra coins are \$5.00.

## TALES OF THE 55<sup>TH</sup>

The fifth edition of the "Tales of the 55<sup>th</sup>" was held Friday, 18 February 2005, at the Offutt Club.

Opening the 55<sup>th</sup> Wing Birthday Ball weekend, speakers from various eras of 55<sup>th</sup> heritage tell their tales. It is one more opportunity for 55<sup>th</sup> alums, both local and out-of-towners, and active duty troops to mingle, and relive, or learn of, some significant stories from the **Fightin' Fifty-Fifth's** history.

This year's event was tri-sponsored by the 55<sup>th</sup> SRW Association; the Strategic Roost, Association of Old Crows; and the local Curtis E. LeMay Chapter, Order of Daedalions.

(LtCol Ricky McMahon dubbed the weekend gathering as "a yearly winter migration to Recca", since the 55<sup>th</sup> is the equivalent to Mecca for all recon dogs. So, "Return to Recca" is now part of the 55<sup>th</sup> lexicon. Max.)

The largest crowd ever, 250+ standing room only, attended this year to hear Master of Ceremonies Robb Hoover and **BGen Craig Koziol**, 55<sup>th</sup> Wing Commander, make opening remarks, after the ringing of the historic ceremonial 55th bell by **Harry Tull**, **Arlen Howe**, and **Chuck Meyer**.

John Wagner, a veteran 55<sup>th</sup> SRW navigator related a few vignettes from the RB-50 era. Tom Butler narrated the details of an incident when an E4B collided with a flock of snow geese on takeoff from Offutt in December 1987 doing severe damage to one engine and lots of sheet metal. (Some 200 geese didn't fare to well, either.)

**MSgt Brian Martin,** a 55th Wing security policeman, told of his experiences during the Iraqi war operations at Tallil AB, Iraq, in 2004. The first female 'Tales' speaker, **LtCol Becky Weirick**, 55<sup>th</sup> Contracting Sqd Commander, had many unique



experiences after being sent to train Iraqi garrison commanders. Her challenges were daunting, indeed, and even more so as an American woman officer vying for acceptance and respect among the Iraqi officers and troops.

The event was highlighted with the presentation by **Colonel (Ret) Bruce Olmstead** of his recently awarded Silver Star (43 years after the RB-47 1 July 1960 shootdown and imprisonment of him and **Col (Ret) John McKone**), to the 55<sup>th</sup> Wing as a tribute to those who served in the Wing, past, present, and future. BGen Koziol accepted the medal on behalf of the Wing.

## \* \* \* \* \* \* 55<sup>th</sup> WING HALL OF FAME

In 2003 the **55<sup>th</sup>SRW Association** assumed the administrative lead for the selection process of the **55<sup>th</sup> Wing** Hall of Fame. Nominees for induction are solicited each year for selection. The inductees are announced annually in conjunction with of the **55<sup>th</sup> Wing** Birthday Ball.

That process has been an evolving one for a number of years, and this year an Association presidential appointed committee continued the selection process under the able leadership of Assn Awards Chairman Mike Cook.

The inductees for 2005 are from two distinct eras of the 55<sup>th</sup>:

LtCol (Ret) Warren (Pappy) Cole is an authentic strategic recon pioneer from the arduous days before and during the Korean War, and the early years of the Cold War.

He commanded a select RB-50 select crew on 85 challenging operational missions, which often required overflight of hostile Russian, Chinese and North Korean territories. Cole and his crewmembers helped establish the foundation of the history of the **Fightin' Fifty-Fifth's** recon program.

**Major (Ret) Thomas (Loose) Lane** was recognized for his far reaching and lasting contributions to the 55<sup>th</sup> Wing's RC-135 fleet in the areas of research, development and procurement of equipment and upgrades, and in flight training requirements, both as an active duty instructor navigator and as a contractor.



## THE 55<sup>TH</sup> SRW ASSOCIATION AWARD FOR EXCELLENCE

The 55<sup>th</sup> SRW Association Annual Award for Excellence is presented to that individual, crew, group, or organization that best exemplifies the basic tenants of the 55<sup>th</sup> SRW Association.

The award winners are announced at the annual 55<sup>th</sup> Wing Birthday Ball and at 55<sup>th</sup>SRWA reunions. Their names are inscribed on the base of the trophy and they receive a representative plaque.

The winner of the 2004 award is **TSgt Terry C. Hunt**, the Enlisted Manager of the Pediatric Clinic of the Ehrling Berquist Hospital at Offutt AFB, NE

TSgt Hunt's superior performance and outstanding professionalism had been recognized by his commanders and supervisors with many awards within the wing and several nominations for higher HQ commendations.

The previous award recipients are LtCol Ricky McMahon, 338<sup>th</sup> Combat Training Squadron commander, for 2000; and MSgt Steven and MSgt Lisa Haggett, 55<sup>th</sup> Wing Command Section, for 2001; LtCol Kurt Kramer, 38<sup>th</sup> RS commander, 2002; and Col (select) Glen Gulleckson, 343<sup>rd</sup> RS commander, 2003.
